The Concord Model Railroad Show was held on August 14, 2022 at the Everett Arena in Concord NH. The Seacoast Division had a table which had applications, information, magazine samples, and display items. The table was manned by Tage Erickson, Nelson Lemay, Jay Ehlen and Glenn Mitchell. The show attendance appeared to back to pre-Covid levels.

One former member, Mike Grahame, rejoined the NMRA with a regular membership. No potential members signed up using a RailPass.

Multiple kits and Seacoast patches were sold totaling \$42.00 which was forwarded to the treasurer.

One former NMRA member (he did not offer his name) stopped at the table and stated that he had transferred into the Seacoast Division and went to an Event sometime in the past. He stated that he was not introduced or approached by anyone from the Seacoast Division and has since quit the NMRA. Unfortunately this has been a recurring problem at our events and needs to be addressed by the Board of Directors.

Another show attendee who gave his name as Dave Harris discussed how he was not a "computer person" and wanted to get the NMRA national magazine in the traditional paper magazine format, but the new \$92.00 annual dues was prohibitive and he is no longer an NMRA member. Name Badges

Glenn asked me to see about getting Seacoast name badges for members who want them. I have been trading emails with Geoff Anthony (who used to handle the name badges), DownEast Engraving, Inc. in Naples, ME (the folks who made the badges in the past), Glenn and Dave Kotsonis.

Previous

Here is what we used to do:

- Anyone who wanted a name tag would fill out the order form and send it and a check made out to the Seacoast Division to Geoff Anthony.
- Geoff would then forward the checks and order forms to the Division treasurer (different people over the years).
- The Division treasurer would then send the order forms and a check made out for the total cost of the order to DownEast Engraving.
- DownEast Engraving would send the completed badges to Geoff.
- Geoff would hand out the badges at the next Division event, or mail them to members who had paid the postage cost up front.
- Badges used to cost \$5.00 and the postage to have Geoff mail it to you was \$3.50.
- Geoff used to send badges to DownEast Engraving in batches of 10, so there was sometimes a wait between when you sent him the form and check and when the badge was made.

Current

DownEast Engraving provided the following update:

- They still have the artwork and templates for the name badges.
- Badges will now cost \$6.00
- Postage/shipping is now \$3.00
- They are willing to accept orders from individual members.
- It will take them about a week to process an order and ship the completed badge.

Proposed

- Provide an order form so members can order individual name badges directly from DownEast Engraving (see the example draft order form).
 - This eliminates two middlemen—Geoff (or me) and the Division Treasurer
 - This speeds up the process because members don't have to wait for the paperwork to go from Geoff to Dave to DownEast engraving
