Those of you who attended the Hyannis convention might have noticed me in the Model Contest Room, rather than the Photo Contest Room where I've been found at recent conventions. I had to substitute for Don Howd, who was ill. Though Don may have thought he was saddling me with a tough job, I enjoyed the return to my old haunts.

We had a super sampler of good modeling to judge. Brian Curry floored us all with his N gauge models, detailed to the maximum. I was really impressed with the fact that the details and the construction were not composed of bulky, out-of-scale features. Instead, they were to scale, finely and fully detailed models. The finishes were attractive and consistent.

Kip Grant and Paul Lessard's models were of particular interest to me as well. I'd like to have those models on my layout. And of course, Bob Bird and Ed Bommer offered models that were inspirational and instructive.

What do you thionk these gentlemen got out of this contest? Oh sure, they got the thrill of competition. Beyond that, I'd be willing to guess, they got a real sense of satisfaction as they discussed and shared their modeling techniques with their audience. While they were worrying about competition, I'll bet they picked up some new ideas, and maybe even a technique to take home. I did, and I only judged the models.

Best of all, these gentlemen have a fine model to put on their railroads. How many times have you built a model for your layout that was not really your best effort, but good enough to fill the need of the layout? These are the so-called "Layout Quality" models. We all build them. You just can't have a model railroad full of contest winners. But the few models that are contest quality really shine. They are great centers of attraction in a scene. They photograph very well, and they truly enhance the realism of the scene.

So, why aren't more of you building models for the model contest? I was swamped with entries in

this contest, but the normal load is well below what a region with 700 members could offer. If you are worried that you will produce a model that is less than competitive, don't be. We have the "New Modeler" classification to protect you from the big hitters. As you build models and expose them to judging, you will find what makes a competitive model.



Try a diorama for your first effort. Build a convincing, highly detailed scene. Make everything you can make, well. Buy what you can't. Use photos of real scenes to get ideas on what details should be present. Talk to some other modelers and get their opinions.

Don't sell the model short by leaving out in-terior details. Be creative. Don't rush. Start the model now for the Stratford convention. Enjoy the experience. Imagine how good the model will look on your layout. If you have questions on judging is-sues, you can Email me and I'll answer them. Or, if you want to swap techniques, that's good too.

See you at Stratford. Oh, and take some good photos of your model for the photo contest!



SINGLE MEMBERSHIP The time has Come

There are over 2200 NMRA members living within the Northeastern Region, but currently only 709 of them are NER members! That is only part of the story. In August 1994, there were 846 NER members. That is a 16% drop in less than four years. Unless we turn this trend around, the NER cannot continue to exist as we know it. When we recruit new members, we need to convince these people of the advantages of membership at both the regional and divisional levels as well.

However, the most effective way for the Region to increase its membership is to bring those non-NER NMRA members into the Region. The Pacific Northwest Region (PNR) instituted a pilot program with the NMRA several years ago to provide a Single Membership to all those NMRA members living within its region. It has been a huge success. Before Single Membership, the PNR had approximately 900 members out of a total 1670 NMRA members residing in the Region. Two years later the PNR had 1400 members! Today, less than 10 NMRA members have decided not to enter into this program and join the PNR.

I have been communicating over the last ten months with Roger Ferris, the PNR Trustee who implemented Single Membership in the PNR, and Connie Rudder, our NMRA Administration Department Manager, regarding this program. Connie came to our recent convention in Hyannis, Massachusetts, to present this program to our BOD. From the questions asked and the comments made by the Board, I believe we could start implementation of this program before the end of the year. We still need to finalize our division boundaries to National as well as the details of implementing the Single Membership Program in the NER.

What is Single Membership? It is a program that is being provided by National whereby your National and Region membership renewal will be all-inclusive on one form, payable with one check. The NER will provide National with a copy of our dues structure and National will prepare a renewal notice with one dues rate based on the combined dues. National will send first, second and third renewal notices to all NMRA members residing in the Region and provide a listing of all applications received with full payment. On the tenth of each month, National will send the NER a check for dues collected the previous month.

National will provide the above service to the NER at no cost for the first year. Thereafter, we will be charged \$1.00 per member for this service. Considering the cost of first class postage, which we use, as well as the renewal forms and envelopes, this will cost us about the same as we would pay for sending three renewal notices. Yes, I know Ron doesn't usually have to send out that many notices, but don't forget Ron is a volunteer, whereas National has a paid staff. Also, the projected increase in membership would provide greater economies of scale for other services the Region provides, such as the Coupler, and administering the Achievement Program, and Model, Photo and Craft contests at our conventions.



The PNR has implemented this program down to the division level in one step. Their reason for doing this is that, in general, their division programs were stronger than their region program. The NER has a fairly strong regional program with a long tradition of two conventions a year. Our divisions, on the other hand, run from several very strong and active organizations to several inactive organizations, with a variety of dues

structures. Consequently it will be much easier to get Single Membership up and running on a regional level first. After we see how it works out, we might the explore the issue of including divisions, but that

is not part of this proposal.

Efforts have been made to implement a Single Membership Program encompassing all of the NMRA in the past. However, no consensus could be reached due to the various dues structures throughout all of the regions and divisions. Now that the PNR has shown that this program can be successfully applied on a region level, several other regions, as well as the NER, are starting to implement it.

As I stated in my September '97 Coupler column, our members are our greatest asset. The NER's shrinking membership roles must be turned around. In order to attract and retain members, we will need to maintain and improve our member services. We shall continue to look for ways to improve the benefits of membership in the NER. If you have any ideas of your own, or questions concerning this program, please contact any member of the BOD. Watch for further announcements regarding the Single Membership Program in the Coupler and Bulletin.

Glenn Glasstetter 655 Hillview Road Richmond, VT 05477

Glenn is the current NER Vice-President. He is a Life member of NMRA and has been active in NER since 1990, attending three national conventions and all but one regional since then. Glenn is a charter member of the Green Mountain Division, a current member and past president of the Northwestern Vermont Model Railroading Society, and was co-chairman of the 1992 spring NER convention. In addition, he has participated in the Achievement Program and is a member of the Layout Design & Operations SIG, and of the C&O Historical Society. He has constructed a large model railroad representing the C&O.

Glenn says, "If elected, and with your support, I will actively pursue three main goals: increase NER membership, enhance member services, and improve communication
