President's Message

The future is you!

I wish to say hello to those whom I have not yet met; also to thank those who started the revitalization of the Seacoast Division, and to thank those who kept the flame alive the years the Division was inactive.

PLANNING

My agenda is very simple: 1) we need to increase membership and representation in all areas of the Division; 2) the Division serves to unite the model railroaders of New Hampshire and Maine and modelers should be made aware of that fact; and, 3) the Division can and should help individual modelers, groups and clubs in both states by supporting clinics, model contests and the NMRA Achievement Program.

As a Division, we should not do what others—divisions, regions and national and the model rail press—already do. There already are enough model railroad shows, new product columns and coverage of national and regional events. We ought to focus on our area and our modelers. We need your submissions to the Editor to maintain our focus. Please help.

Many of you have been involved in club shows and know the work, planning and exhaustion accompanying such an event. My opinion, shared by others, is that it would be darned nice if someone outside the club or sponsoring group would come in and run, or help run, contests, clinics and Achievement Program judging. It would certainly add to the quality of our shows without a lot of extra work

Larry Cannon is new Seacoast Division president

The Seacoast Division, NMRA, has elected award-winning model railroader Larry Cannon of Auburn, Maine, as its president for 1999. Larry was vice-president in 1998.

In his first president's message, Larry has listed a three-point agenda for his term in office: Increased membership, increased awareness of the unity strengths of the Division for modelers in Maine and New Hampshire and more help for modelers, groups and clubs by supporting clinics, model contests, photo contests and the NMRA Achievement Program.

Larry also has been elected secretary of

the Northeastern Region, NMRA and will continue as the Seacoast Division's Achievement Program chairman.

A model railroader since age 6, Larry has been a large-scale modeler since 1993. He rejoined the NMRA in 1994. He is actively participating in the Achievement Program, winning Merit Awards at both the regional and national levels, and is working to complete his requirements to earn the NMRA designation Master Model Railroader.

He also has published two articles in the NMRA Bulletin, and has pledged to lead (continued on page 3)

NMRA membership continues to offer individual model railroaders fellowship, a monthly magazine, a reference library, an achievement program, contests, local activities, a pass exchange, access to Master Model Railroaders, standards, recommended practices, periodical index, directory of information, glossary of terms, estate counseling, retailer's network, modeler's aid, etc. How about you? AMTRAK'S "GOLDEN" SPIKE

Representatives of Amtrak, Guilford Transportation Industries, the Maine Department of Transportation and TrainRiders/Northeast recently drove ceremonial spikes into rail ties on the GTI mainline tracks behind the old Maine Central Office Building in Portland. The symbolic ceremony signaled the start of rehabilitation of the Portland-Boston track on

which Amtrak train service is to begin. It's been a long haul for supporters of the service, who began lobbying efforts 10 years ago. Now, the most reliable estimate for a start-up date is sometime late in the year 2000. Rumors indicate the Portland Amtrak station will not be at that location, where Union Station was located. The talk is that Amtrak will use a facility at Thompson's Point, adjacent to the former Maine Central steam locomotive shop facility and not far from the current Concord Trailways bus terminal.

TRIVIA ANSWER

There are 15,000 public highway-rail grade crossings on the huge BNSF, almost half of them equipped with active warning systems-flashing lights or bells and gates, according to the Denver Post newspaper. The information was included in an article headlined "Railroads post emergency numbers at crossings." The National transportation Safety Board recommended that all major railroads "devise and implement, without delay, a 24-hour toll-free emergency notification telephone number for use by the public" following a May 2, 1995 Amtrak-tractor-trailer collision that injured 33 of the 293 passengers on board the 16-car Silver Star train. BNSF plans include posting signs at all private crossings, too.

VOLUNTEERS NEEDED

This outside participation should not, in fairness, always be performed by the same group of people. I am attempting to enlist a dozen people around the Division who would do, or be willing to learn how to do, contest or photo judging. It is not as hard as it may appear; even I learned how to do photo judging and no one has threatenened my life yet.

Tim Byrne of Scarborough, Maine, has volunteered to head our Photo Contest effort. Dwight Smith of Kearsage, N.H., has offered the same for Model Contests. Both have notable records of participation in the hobby of model railroading, and I am glad to have their support. Three other people have agreed to help them out. We need about a dozen other part-time people, divided in the two contest areas, to make sponsoring contests an

easily achievable tasks within the Division. YOU CAN DO IT

Clinics (believe it or not!) will take care of themselves with nominal effort. For the past two years, I have helped with the Rail Clinic run in March in North Yarmouth, Maine, by the Great Falls Model Railroad Club, my home club.
