

"New" Maine Central Power

A group of 20 Canadian National GP40-2LW and GP40-2W units has been acquired by Guilford Rail System. The used 3,000 horsepower locomotives will be delivered to Guilford in Buffalo, N.Y., where Ebenezer Car Co. will paint them in the GRS scheme. New locomotive numbers will be 500-519, and the units will be Maine Central-owned. The CN GP40s are the first to be painted off-line since the former D&H 7600-series GP39-2s were rebuilt and repainted by Morrison-Knudsen in the early 1980s. Our thanks to Jack Armstrong, *RailPace* magazine columnist for the details.

Edaville Reborn

Seacoast member Roger Wilson of Cape Elizabeth and Maine Narrow Gauge authority Bob MacDonald of Gray visited Edaville recently. Bob E-mailed the following information: "Though not so much Maine Narrow Gauge, per se, now (Edaville) is actually bigger than evermore lights, exhibits, and things for kids. Plans for much more, too. Jack Flagg has a 'thing' about cabooses. There must be a dozen or more around the grounds. (He) has a Santa Fe diesel, I think an F-7 (whatever) with the Santa Fe warbonnet design. The engine might be a B&M in Santa Fe colors. All the old-time signals around the loop are functional. Worthwhile seeing." Thanks for the report, Roger and Bob.

Prototype Railspotting

There were some interesting freight cars waiting to be loaded at Portland Terminal Co. Yard 8, Commercial St., Portland, in early December. Seven triple hoppers, painted black, were lettered MEC (Maine Central): 2016, 2019, 2020, 2022, 2011, 2010 and 2014. Last in line was B&M 1155, one of the smaller triple hoppers that hauls coal from Merrill's Wharf in Portland to the paper mill in Rumford. The MEC cars had new stencils. Any idea about a former owner?

And, on Christmas Eve, two of the new MEC-owned ex-CN GP40s (see above) visited Rigby Yard, So. Portland. A helpful engineer separated the bright, shiny widecab 506 and 513 from a string of six diesel units that had arrived earlier in the morning on an eastbound freight. We'll have modeling tips in the next issue.

Minutes of Seacoast Division meeting on October 21, 2000.

The meeting of the Division opened at 1:30 p.m. in Rochester, N.H., with four trustees and seven members attending. Membership now is 57, including two new members.

Our treasurer, Tim Byrne, has resigned because of personal reasons, and all funds and records have been turned over to the president. Pres. Larry Cannon has opened a new account that has a balance of \$816.79; outstanding bills are around \$180.00.

The minutes of the previous meeting were accepted as read.

Larry Cannon and Dwight Smith were nominated for reelection to the board, and as there were not other nominations,
they were elected.

The regular Director's meeting was recessed.

Pres. Larry Cannon picked Richard Breton as Vice-President, Terry King as Secretary and Tom Coulombe as Treasurer. The Board of Directors accepted these presidential appointments.

The regular meeting resumed with a discussion about the Division hosting a Northeastern Region convention in Portland, Maine, in the spring of 2002. A number of volunteers have been recruited so far. A number of hotels in Portland have expressed an interest in hosting the convention. The convention will be a little different as there will be no fan trip. There will be mini-trips to places like the Seashore Trolley Museum, The Maine Narrow Gauge Railroad Co. & Museum and the WW&F Railroad in Alna, with other places being considered, too. could be a shopping excursion to L.L. Bean's in Freeport and/or The Old Port Exchange area of downtown Portland.

Good clinics will be a strong point of the convention, as it was in Lyndonville, Vt. last spring.

A motion was made, and passed, to go ahead with the convention.

Paul Lessard will write the clinic descriptions. Larry Cannon will be the convention chairman, and Sandy Roberts will be in charge of transportation. It was voted to let Larry Cannon handle the site selection.

The next meetings will be on January 13th, 2001, in Rochester, N.H., March 10th, 2001 in Lewiston and in North Conway/ Intervale in May.
